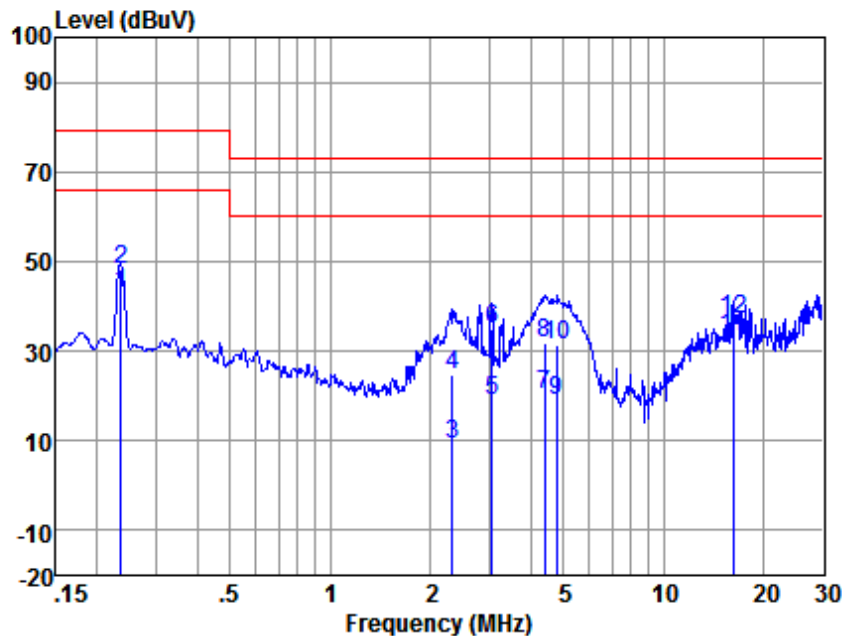

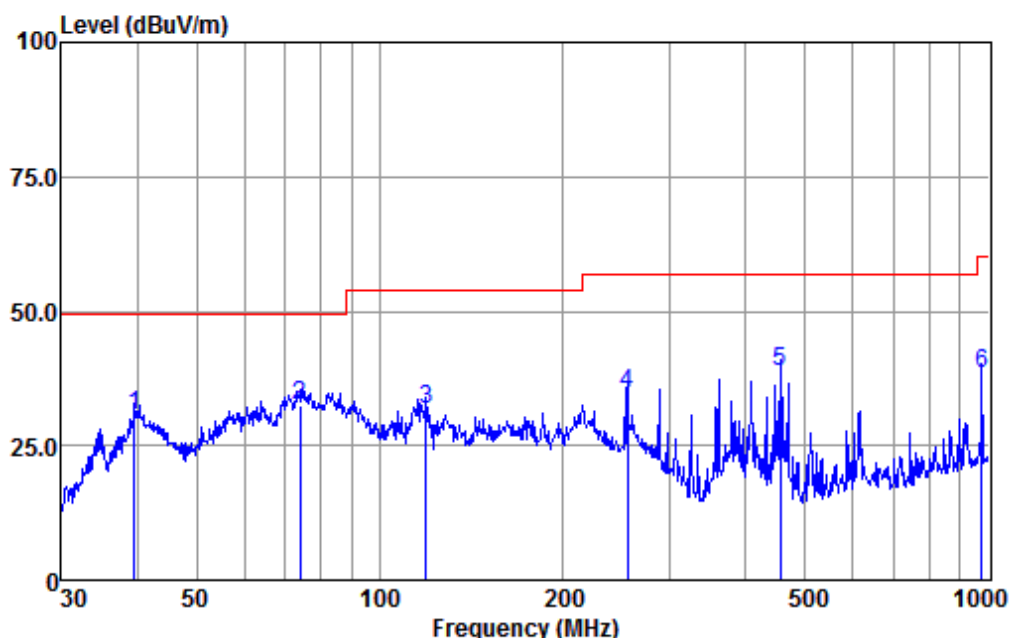

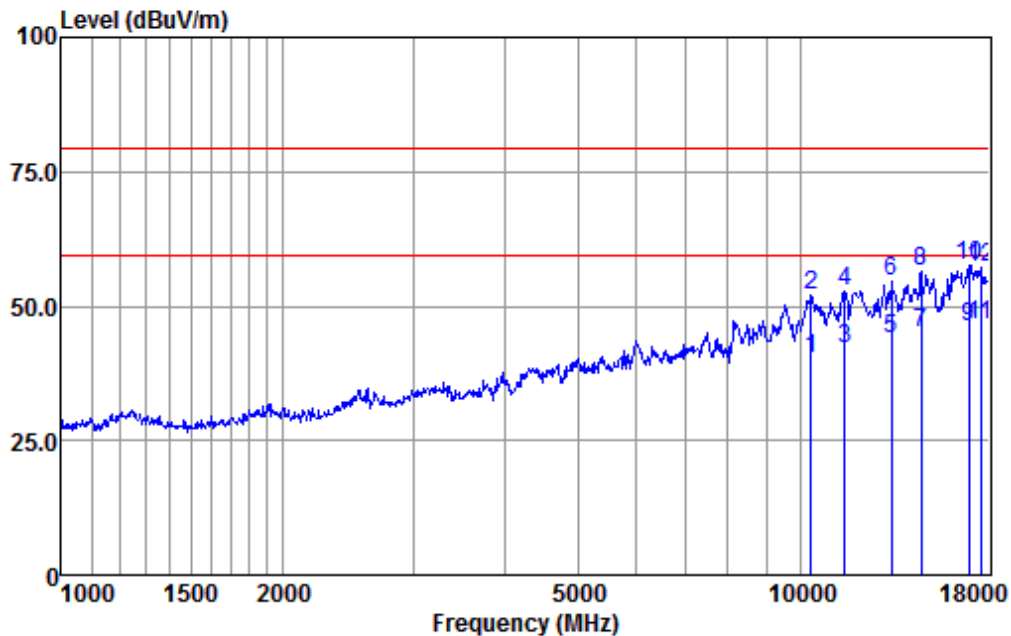

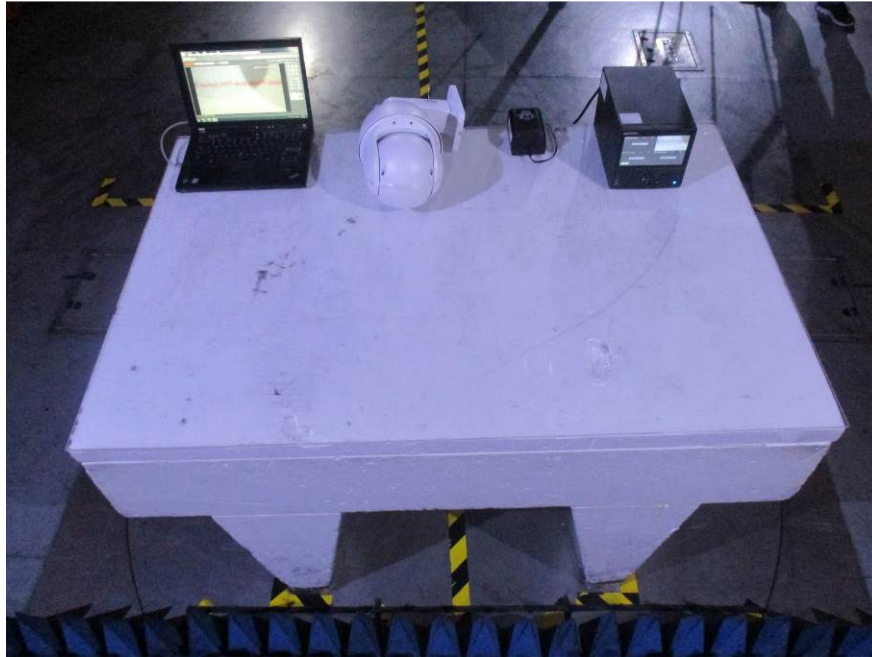
### 7.1 Conducted Emissions at Mains Terminals (150kHz-30MHz) Test Setup
